

A RESOLUTION ESTABLISHING A SOLID WASTE AND RECYCLING FEE SCHEDULE

WHEREAS, the City Council of the City of Carbondale by Ordinance No. 93-74 adopted the Revised Code of the City of Carbondale which includes Title 10, Solid Waste Collection and Storage; and

WHEREAS, Section 10-1-4 of the Carbondale Revised Code provides for the establishment of refuse, landscape waste, and recycling fees by Resolution of the City Council; and

WHEREAS, pursuant to Resolution 2011-R-54 passed on September 20, 2011, the City Council established fees for the City's solid waste and recycling program that have been in effect since that time; and

WHEREAS, the fees charged by the City must be periodically adjusted to provide adequate revenues to operate the Solid Waste and Recycling Programs; and

WHEREAS, the City Council of the City of Carbondale, Illinois, finds that it is in the best interest of the City and appropriate to amend the Solid Waste and Recycling Program fees in order to adequately fund the operation of the Solid Waste and Recycling Programs.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CARBONDALE, ILLINOIS, AS FOLLOWS:

1. That the Solid Waste and Recycling Program Fee Schedule be and is hereby established effective with bills issued on or after May 1, 2014, by adopting Exhibit A, "Solid Waste and Recycling Fee Schedule", which is attached hereto and incorporated herein.

2. That the Solid Waste and Recycling Program Fees previously established by

Resolution 2008-R-54 shall no longer be in effect for bills issued on or after May 1, 2014.

3. That the City Manager of the City of Carbondale, Illinois, be and is hereby authorized to do any and all things reasonable, necessary and proper to carry out the intent and purposes of this Resolution.

4. That this Resolution be spread at length upon the minute records of the City Council of the City of Carbondale, Illinois.

Exhibit A to Resolution 2014 - R - 18

**Solid Waste and Recycling Fee Schedule
Effective May 1, 2014; May 1, 2015; May 1, 2016**

A. The fees for City refuse collection service shall be as follows:

1. For regular residential refuse collection in approved refuse containers and plastic bags the fees shall be as follows:

a. When the City provides residential refuse collection services at curbside to qualifying buildings and/or premises which regularly generate one (1) cubic yard (200 gallons) or less of refuse per week, the fee for collection service provided once each week per dwelling or small business establishment shall be:

Beginning on May 1, 2014, \$11.60 per month
Beginning on May 1, 2015, \$11.80 per month
Beginning on May 1, 2016, \$12.00 per month

The above monthly fees include a one dollar (\$1.00) solid waste equipment replacement fee.

b. When the City provides residential refuse collection services at curbside to a rooming house the fee for collection service provided once each week shall be as stated above per dwelling unit served plus one-half that rate per month for each bedroom over four available for rent and/or lease in the dwelling unit.

c. Should a qualifying residential refuse customer's volume exceed the one (1) cubic yard (200 gallon) limit, on their regular scheduled collection day, Extra Volume Charges shall be automatically imposed according to the following timed collection rates:

Less than two (2) minutes, \$10.00 per occurrence
Two (2) to four (4) minutes, \$20.00 per occurrence
Four (4) to six (6) minutes, \$30.00 per occurrence
Greater than six (6) minutes, \$30.00 plus \$7.50 for each additional minute or fraction thereof.

2. Callback Fees:

a. When City refuse and/or recycling truck(s) are requested to make a return trip to collect refuse and/or recycling that was set out late on the regular collection day for a property and/or premise; an additional fee of \$10.00 shall be automatically imposed for said return trip.

3. For the commercial dumpster collection service:

a. When the City provides commercial dumpster collection service to a qualified building and/or premise, the fee per month for weekly collection service of one (1) container shall be:

Beginning on May 1, 2014, \$43.00 per month
Beginning on May 1, 2015, \$44.00 per month
Beginning on May 1, 2016, \$45.00 per month

The above rates shall be multiplied times the number of collections and times the number of dumpsters collected each week to determine a total price for multiple day and/or multiple dumpster collection for each customer.

- b. When the City provides commercial dumpster collection to a non-qualified building and/or premise, the fee per month for weekly collection service of one (1) container shall be:

Beginning on May 1, 2014, \$75.25 per month
Beginning on May 1, 2015, \$77.00 per month
Beginning on May 1, 2016, \$78.75 per month

Service shall be one (1) dumpster collected one (1) time per week.

- B. The fees for City landscape and special waste collection services shall be paid via the purchase of prepayment stickers and affixing the required number of stickers to the items as specified below.

1. When the City provides landscape waste collection services at curbside for landscape waste contained in clear plastic bags, bundles, or individual pieces of wood to any building or premise, one (1) City Landscape and Special Waste Collection Sticker shall be affixed to each bag, bundle, and/or individual item of wood which has been placed at curbside for collection.
2. When the City provides special waste collection services at the curbside for white goods without refrigerant in them (i.e. major appliances such as water heaters, stoves, microwaves, clothes washers, and driers) ten (10) City Landscape and Special Waste Stickers shall be affixed to each item which has been placed at the curbside for collection.
3. When the City provides special waste collection services at the curbside for white goods with refrigerant in them (i.e. major appliances refrigerators, window air conditioners, and freezers) twenty (20) City Landscape and Special Waste Stickers shall be affixed to each item which has been placed at the curbside for collection.
4. When the City provides special waste collection services at the curbside for passenger car and light truck tires that are not mounted on a rim or wheel four (4) City Landscape and Special Waste Stickers shall be affixed to each item which has been placed at the curbside for collection.
5. When the City provides special waste collection services at the curbside for passenger car and light truck tires that are mounted on a rim or wheel six (6) City Landscape and Special Waste Stickers shall be affixed to each item which has been placed at the curbside for collection.

C. The fees for Vacuum Leaf Collection Services shall be as follows:

1. When Seasonal Vacuum Leaf Collection Services (November, December and January of each year) are provided to a building and/or premise for leaves raked loose to the curbside, the fee for collecting and disposing of loose leaves shall be:

Beginning on November 1, 2014, \$25.00 per pile

2. When Vacuum Leaf Collection Services (February through October of each year) are provided to a building and/or premise for leaves raked loose to the curbside, the fee for collecting and disposing of loose leaves shall be:

Beginning on May 1, 2014, \$35.00 per pile

D. The fee for the City's Curbside Recycling program shall be as follows:

Beginning on May 1, 2014, \$3.00 per month

Beginning on May 1, 2015, \$3.10 per month

Beginning on May 1, 2016, \$3.20 per month

E. Owners or occupants of properties receiving City Designated Solid Waste Collections and/or Voluntary Extra Solid Waste Collections will be charged at the following rates for these services:

1. The fee shall be \$15.00 plus \$7.50 per minute after the first minute of collection time, as noted by the collector, rounded up to the next whole minute.

F. Billing/Payment of fees:

1. The fees for all Refuse, Recycling, Landscape Waste and Special Solid Waste Curbside Collection services as noted herein will be billed as provided for in Section 10-1-5 of the Carbondale Revised Code.
2. The purchase and affixing of the appropriate number of City Landscape and Special Waste Collection Stickers shall be considered as pre-payment for the fees required for said services. The fee for each City Landscape and Special Waste Collection sticker purchased directly by users from the City shall be \$1.00 each. The Finance Director may sell City Landscape and Special Waste Collection stickers to approved distributor/merchants in bulk for resale to individual users. The charge to these distributor/merchants shall not be less than \$0.95 per sticker. The distributor/merchants shall sell the stickers to users for no more than \$1.00 each.

G. Definitions in Section 10-1-1 of the Revised Code of the City of Carbondale shall apply to the terms used in the fee schedule.
